Chief Executive Officer Monica Padilla provided a report which included:

- A reminder of a Board of Directors Special Meeting, scheduled for Friday, December 12, 2025 at 10:00 a.m. at the Juniper Hotel in Cupertino followed by lunch;
- An invitation to hear guest speaker Severin Borenstein at the Juniper Hotel in Cupertino on December 12, 2025 at 8:30 a.m.; and
- Zoe Elizabeth, Director of Decarbonization Policy and Community Strategies, shared updates on the progress of SVCE's new headquarters

Staff responded to questions and comments regarding anticipated move-in date to the new headquarters and terms of the existing office lease.

Vice Chair Meadows opened Public Comment.

Vice Chair Meadows closed Public Comment.

3) Recommend the Silicon Valley Clean Energy Board of Directors Approve the Proposed Updated Fiscal Year 2025-2026 Budget and 2026 Rate Changes (Action)

Amrit Singh, Chief Financial Officer, reviewed the updated fiscal year 2025-2026 budget and five-year financial forecast, and reviewed the updated budget and proposed SVCE rate changes. The main areas of discussion included:

- Highlights of the updated financial forecast, showing that five-year margins remained negative under a 'business-as-usual' scenario, a fiscal year 2026 draw on reserves of \$60 million (up from \$40 million), and a proposed 1% customer discount and additional \$12 bill credit for low-income customers;
- Comparison of the adopted and updated budget;
- SVCE's financial reserves outlook and management; and
- SVCE's rates for 2026

Staff responded to questions and comments on the transmission and distribution (T&D) rates, the proposed 1% customer discount, anticipated future Power Charge Indifference Adjustment (PCIA) fees, if the model used assumed future prepaids, future interest rates and interest income, potential load growth effects, recommended Days Cash On Hand (DCOH) and credit rating agency feedback, how SVCE rates and information are reported to credit rating agencies, reserves targets and DCOH, SVCE's building fund, the proposed GreenPrime rate, and the low income monthly credit.

Vice Chair Meadows opened Public Comment.

Bruce Karney commented on the PCIA, and questioned if SVCE staff or CalCCA has attempted to understand how the PCIA will decline over time.

Vice Chair Meadows closed Public Comment.

MOTION: Director Tyson moved and Director Walia seconded the motion to recommend the SVCE Board of Directors approve the updated Fiscal Year 2025-26 operating budget that includes:

1. **Implementing SVCE generation rates to establish a 1% discount to PG&E's applicable generation rates,**
2. **Providing a monthly bill credit of \$12 for CARE/FERA customers,**
3. **Approving the new GreenPrime rate of \$0.0074/kWh (\$7.40/MWh)**
4. **\$5.5 million to the building fund.**

The motion carried with Chair Martinez Beltran absent.



4) Community Grants Program Development (Informational)

Director of Decarbonization Policy and Community Strategies Elizabeth introduced the item and Jessica Cornejo, Decarbonization and Community Strategies Lead, provided a presentation which included background information on previous grants, an overview of the Community Grants, and review of next steps.

Staff responded to questions regarding member agencies who did not apply for non-competitive grants, and reminding Board members of approaching grant deadlines and for information awareness.

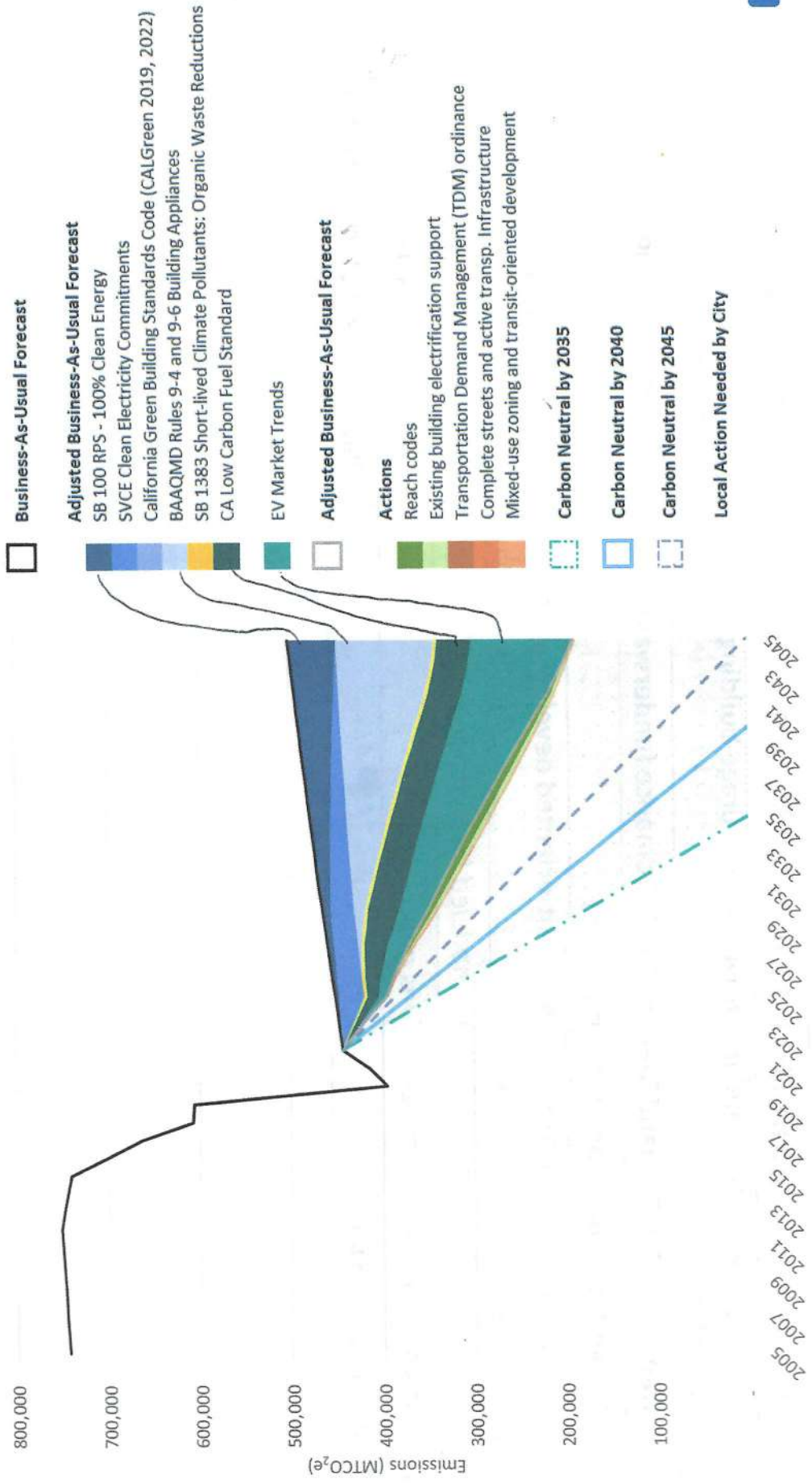

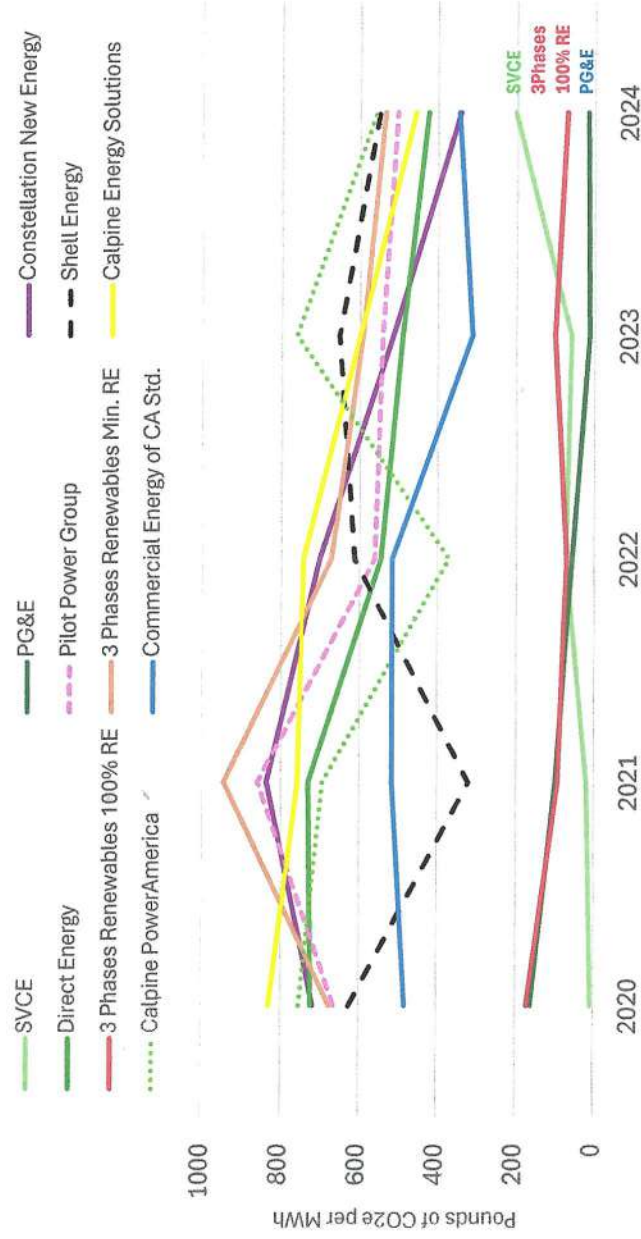

Modeled Emissions and Emissions Reductions



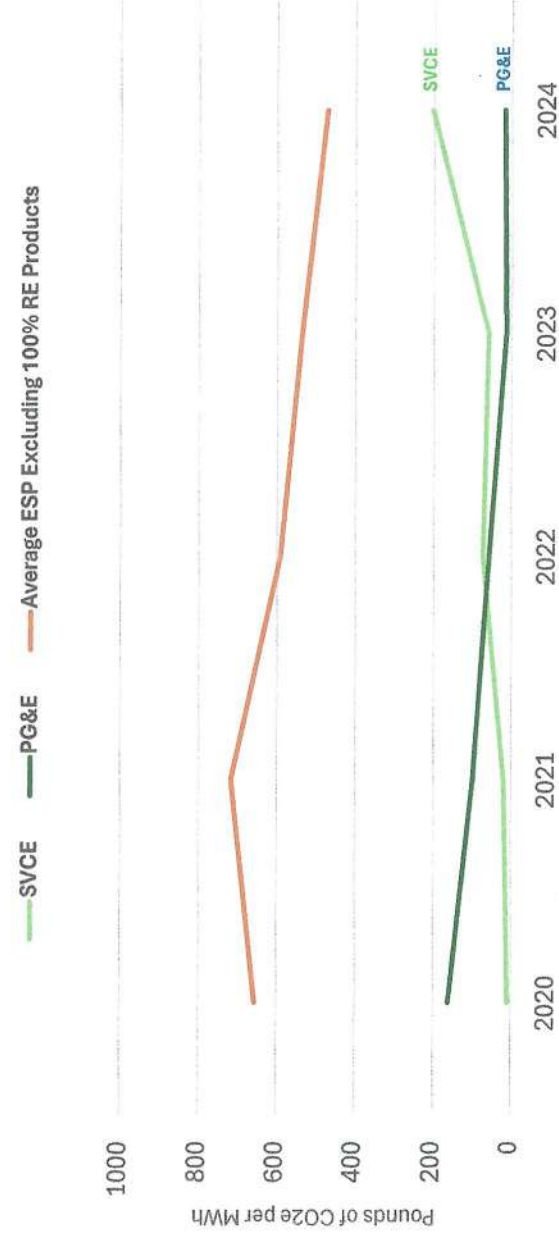
Dirty Electricity from ESPs

RECOMMENDATION

Staff recommends the Silicon Valley Clean Energy (SVCE) Executive Committee elect a 2026 Chair and Vice Chair to preside over committee meetings.

BACKGROUND

As an appointed ongoing committee of the SVCE Board of Directors (Board), Executive Committee meetings are public and subject to the Ralph M. Brown Act. Per [SVCE's Operating Rules and Regulations \(ORRs\)](#), the Executive Committee is appointed at the annual meeting in January and there are no limits on the number of terms that a Director may serve on a committee. The Chair and Vice Chair will be selected by the Executive Committee by an affirmative vote of a majority of all members of the entire committee ([SVCE's Joint Powers Agreement](#), Section 4.9.1).

ANALYSIS & DISCUSSION

With Executive Committee appointments made at the January 14, 2026 Board meeting, staff recommends committee members appoint a Chair and Vice Chair to preside over meetings for 2026. Any member of the Executive Committee may serve as Chair or Vice Chair and there are no term limits; per the ORRs, the Nominating Committee considers it a best practice to recommend the Board Vice Chair to serve as the Chair of the Executive Committee.

The 2025 positions were held by Director Yvonne Martinez Beltran as Chair, and Director Sally Meadows as Vice Chair.

Process and Procedure for Chair/Vice Selection

At the meeting, those interested in the role of 2026 Chair or Vice Chair will inform the Chair by self-nomination; nominations of other members of the committee will also be accepted. Once all nominations have been made, each interested member will be given an opportunity to make a statement.

If there is more than one person interested in either role, a roll call vote will be performed by the Board Clerk. Each committee member will be asked to vote for their selection by name. For this Executive Committee of six members, a vote of four members will be required to identify the Chair/Vice Chair. A ratification vote will be taken to solidify the selection.

In the event four votes is not reached, the top two candidates with the most votes will continue for additional rounds of votes until four votes is received.

RECOMMENDATION

Staff recommends the Silicon Valley Clean Energy (SVCE) Executive Committee approve an ongoing meeting date and time for 2026 Executive Committee meetings. Staff proposes to keep the existing schedule of every fourth Friday of the month at 10:00 a.m., a summer recess in June, and a later start time in February due to an existing conflict.

BACKGROUND

In June 2016, the SVCE Board of Directors (Board) approved the formation of the Executive Committee with the role of advising the CEO and Board on matters pertaining to the operations of SVCE. The approved role of the Executive Committee is advisory to the Board unless the Board directs or delegates specific decision-making authority to the Executive Committee, such as delegating final approval of a professional services agreement.

For reference, the Executive Committee has met on Fridays since 2019. The 2025 Executive Committee meetings were held every fourth Friday of the month at 10:00 a.m. and the July meeting was cancelled.

ANALYSIS & DISCUSSION

New members of the 2026 Executive Committee were selected at the January 14, 2026 Board of Directors meeting. The dates and times for the Executive Committee meetings need to be agreed to and approved for the year.

All meetings will be hybrid with the option for committee members to participate in person at the SVCE office or remotely from a publicly accessible and noticed location. Members of the public will be able to attend in person or remotely; all meetings will follow the Ralph M. Brown Act.

RECOMMENDATION

Staff recommends the Silicon Valley Clean Energy (SVCE) Executive Committee recommend the SVCE Board of Directors (Board) approve the proposed changes to SVCE's Hybrid Meetings policy to incorporate California Senate Bill 707 (SB 707).

BACKGROUND

In preparation for the end of the COVID-19 State of Emergency and the ability for local agencies to meet remotely under [Assembly Bill \(AB\) 361](#), the Governor signed [AB 2449](#) on September 13, 2022, which allowed members of a legislative body to meet from a remote location under specific circumstances ("Just Cause" and emergency situations) without having to disclose their location and without 72-hour notice before the meeting, effective January 1, 2023. The SVCE Board expressed interest in the ability to utilize AB 2449 and approved GAP 9: Hybrid Meetings Policy incorporating the new remote meeting options in January 2022.

In October 2025, [SB 707](#) was signed and provides, among other things, alternative teleconferencing options under specific circumstances.

ANALYSIS & DISCUSSION

With the sunset of AB 2449 on January 1, 2026, the SVCE Board is required to use traditional Brown Act rules for any member wishing to participate in a meeting remotely. This includes noticing a remote location on the meeting agenda at least 72 hours in advance of the meeting, and allowing the public to participate in the meeting from the noticed remote location.

Staff will provide a presentation outlining meeting requirements of SB 707, which will provide alternatives to the traditional Brown Act rules (under certain circumstances) and additional requirements of the new legislation.

STRATEGIC PLAN

Amending SVCE's Hybrid Meetings policy supports Goal 9 of the Strategic Plan to "Implement industry best practices to enable data-driven decision making across the organization; enhance systems, standards and procedures to streamline business processes and improve operational effectiveness and reliability (aka SVCE 3.0)."

ALTERNATIVE

Staff is open to suggestions from committee members on additional amendments to the policy.

Item 6: Input on Timing to Solidify Proposals for the Community Space at Silicon Valley Clean Energy Headquarters

RECOMMENDATION

Direct staff to return with recommendations for the Fiscal Year (FY) 27-28 budget for the community space at SVCE's new headquarters at 298 S. Sunnyvale Avenue.

BACKGROUND

In February 2025, SVCE purchased a 28,000-square-foot, two-story building that will serve as the agency's new headquarters. The building was renovated in 2019 but is a shell and SVCE needs to complete the interior build-out prior to occupying the building. SVCE conducted two in-person feedback sessions with staff, the Board, and members of the public to ensure their values, priorities, and needs are considered during the building's design process. The first feedback session entailed an in-person exercise with all staff to discuss the office space. The takeaways from that session included incorporating modular office features for a changing workforce and designing an effective space for individual and collaborative productivity.

The second feedback session was with the Board of Directors and members of the public to solicit input on priorities and values for the Board Chamber and community space while maintaining a focus on financial feasibility. The priority benefits for the community space were engagement for contractors and retailers, workforce education, and public electrification education. Staff presented these takeaways in the May 2025 Executive Committee meeting and shared the feedback with the selected architectures.

Staff have been working diligently to prioritize the office space and Board Chamber with the goal of relocating operations by summer 2026. The building is phased into two parts: Phase 1) the office space and Board Chamber and Phase 2) the community space. Staff is requesting additional time to assess the needs of the community space as outlined in the feedback sessions. Staff will use additional time to conduct a market assessment, cost analysis, community needs assessment and evaluate the building's usage post move-in to better assess the example concepts listed in the feedback session.

ANALYSIS & DISCUSSION

In the January 2026 Board of Directors meeting, the Board approved the contract for the development and construction of SVCE's headquarters in the amount of \$6,554,435 with an allowance for a contingency up to 10% for a maximum of \$7,209,879 ([SVCE Board of Directors meeting, January 14, 2026, Item 1f](#)). The current Board-approved building budget is \$25.5 million. With the building purchase, construction, architect and project manager services, and permit fees, there is an estimated remaining of \$4 million in the budget.

SVCE is undergoing two strategic processes, focusing on financial levers and the Integrated Decarbonization Roadmap. Both are long-term strategies that refine SVCE's goals and milestones and will include updated funding priorities. Build out of the community space will require construction costs and potentially additional

staff resources. Staff feel it would be prudent to complete these two strategic planning processes before finalizing the plan for the community space to ensure the plans for the space align with larger organization objectives and Board direction. In addition, the recommended time frame will allow staff to conduct a market assessment, cost analysis, and a community needs assessment to ensure the highest and best use of SVCE resources. Staff will also evaluate the building's usage post-move-in to examine additional staffing, permitting, and parking needs to support the community space.

STRATEGIC PLAN

Expanding the office falls under Strategic Focus Area #5, Attract & Retain Employees.

ALTERNATIVE

Staff can return to the Executive Committee during the 2025 mid-year fiscal review in June 2026. Staff does not recommend this alternative given the need for further research, feedback, and overlap of the building's construction.

FISCAL IMPACT

The Board of Directors originally approved \$20 million to support the purchase and development of SVCE's new headquarters in the March 2024 Board of Directors meeting ([SVCE Board of Directors meeting, March 13, 2025, Item 4](#)). The Board subsequently approved an additional \$5.5 million for the budget in the December 2025 Board of Directors meeting ([SVCE Board of Directors meeting, December 10, 2025, Item 5](#)). The total building budget is \$25.5 million. This funding will cover the cost of constructing the office space and Board Chamber with an estimated \$4 million remaining for the community space. The community space may require additional funding, which must be approved by the SVCE Board of Directors.
