



SVCE DIY TOOLKIT SWEEPSTAKES OFFICIAL RULES & REGULATIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE ENTRANT'S ODDS OF WINNING.

SWEEPSTAKES PERIOD: The DIY Toolkit Sweepstakes ("Sweepstakes") will be held in four (4) separate rounds (collectively, the "Sweepstakes Period"). Round 1 starts March 4, 2024, at 12:00 AM Pacific Time and closes on March 29, 2024, at 11:59 PM Pacific Time. Round 2 starts June 3, 2024, at 12:00 AM Pacific Time and closes June 28, 2024, at 11:59 PM Pacific Time. Round 3 starts September 2, 2024, at 12:00 AM Pacific Time and closes September 27, 2024, at 11:59 PM Pacific Time. Round 4 starts December 2, 2024, at 12:00 AM Pacific Time and close December 27, 2024, at 11:59 PM Pacific Time (each, a "Round").

SWEEPSTAKES SPONSOR: The Sweepstakes is sponsored by Silicon Valley Clean Energy (SVCE), which has its corporate headquarters at 333 W. El Camino Real, Ste. 330, Sunnyvale, CA 94087. SVCE is responsible for the delivery of the Prize(s) to the winner(s). The SVCE computer is the official time-keeping device for the Sweepstakes.

ELIGIBILITY: This Sweepstakes is open to all customers of SVCE who are 18 years of age or older and a legal resident of the U.S. at the time of entry into the Sweepstakes ("Entrants"). Entrants must be a customer of SVCE prior to the start of the Sweepstakes on March 4, 2024. Only one Entrant per SVCE customer account is allowed. Employees, agents and representatives of SVCE are not eligible to win, nor are the parents, siblings and children of any such employee, agent or representative or any person with whom such employee, agent or representative is domiciled. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and SVCE's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

PRIZES: An electronic drawing will be held on the following dates: Round 1 will be drawn on April 2, 2024; Round 2 on July 2, 2024; Round 3 on October 1, 2024; Round 4 on January 6, 2025. Each prize (each a "Prize" and collectively the "Prizes") consists of an advertised energy saving tool. In Round 1, five (5) winners will each be awarded one (1) portable induction cooktop worth sixty-three dollars (\$63); Round 2, four (4) winners will each be awarded one (1) smart tower fan worth eighty dollars (\$80); Round 3, four (4) winners will each be awarded one (1) smart thermostat worth ninety dollars (\$90); Round 4, two (2) winners will each be awarded one (1) solar portable generator worth two hundred nineteen dollars (\$219). In total, there will be fifteen (15) Prizes awarded during the Sweepstakes Period.

Depending on item availability, the total worth of all of the Prizes is one thousand and four hundred thirty-three dollars (\$1,433). Entrants are only eligible to win one (1) Prize during the entire Sweepstakes Period. (e.g., an Entrant is eligible to win only one (1) portable induction cooktop, or one (1) smart tower fan, or one (1) smart thermostat, or (1) solar portable generator). Prize winners will not be eligible for future SVCE sweepstakes for one year from



date of award. SVCE reserves the right to substitute any Prize for one of equal or greater value if the designated Prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with Prize receipt and/or use.

Once an Entrant has been awarded a Prize, the Entrant is no longer eligible to win another Prize during the Sweepstakes Period. If the Entrant is not awarded a Prize in any given Round, Entrants may submit another entry into any of the subsequent Rounds.

SWEEPSTAKES ODDS: The odds of winning a Prize depend on the number of eligible entries received per Round. The odds of an entry winning any Prize will be the same for any method of entry.

HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. To submit an entry, Entrants must publish a post ("Post") including a photo that Entrant has taken depicting an energy saving tool or device such as a LED lightbulb or window weather-stripping ("Photo") to Facebook, Instagram, LinkedIn, or X (formerly Twitter) and the tag ("Tag") @SVCleanEnergy.

ADDITIONAL METHODS OF SWEEPSTAKES ENTRY. Entrants may instead choose to submit an entry via email to: toolkits@svcleanenergy.org ("Email"). The Email must include an image or screenshot of Entrant's Post with the Photo and Tag.

Entrants may choose to instead submit an entry via mail by sending a 3x5 index card with their printed name, address, telephone number, email address in a postage prepaid envelope addressed to:

All mail-in entries must be postmarked and received by the end of each Round.

All entries shall become the exclusive property of SVCE and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by SVCE. SVCE is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, or misdirected entries, which will be disqualified.

Submitting an entry through mail does not provide any advantage over submitting an entry through an online post or email and submitting an entry through an online post or email does not provide any advantage over submitting an entry via mail.

There is a total limit of one (1) entry per Entrant during each Round using all methods of entry. Different Entrants are not permitted to share the same email address. Any attempt by an Entrant to enter the Sweepstakes using multiple/different email addresses, identities, registrations and



logins, or any other methods will void that Entrant's entries and that Entrant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

AWARD OF PRIZES: Winners will be notified by email within fifteen (15) days of the applicable drawing. Prizes will be awarded only on verification by SVCE that all Sweepstakes requirements have been met by the winners. Each Prize must be accepted as awarded and no substitution, transfer, conversion, or assignment of Prizes will be allowed, except at the discretion of SVCE, who may substitute a Prize of comparable or greater value. The winner will have seven (7) calendar days from notification to accept the Prize by email. SVCE is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner. If a selected winner cannot be contacted within the allotted time, SVCE reserves the right to void that entry and select another winner for that Prize by random drawing.

SWEEPSTAKES GENERAL RULES: By entering the Sweepstakes, Entrants agree to abide by these Official Sweepstakes Rules and Regulations and the decisions of SVCE, which are final.
