

FutureFit Homes Rebates Income Qualifications

SVCE's FutureFit Homes program offers enhanced rebates for income-qualified customers if they meet one of the following criteria:

- 1. California Alternate Rates for Energy Program ("CARE") or Family Electric Rate Assistance Program ("FERA") Enrollment OR
- 2. Another Income-Qualified Program Enrollment OR
- 3. Proof of Qualifying Income

Customers must also meet all requirements outlined in the Participant Agreement and Appliances Specification to be eligible for FutureFit Homes rebates.

1. CARE or FERA Enrollment

When submitting the Rebate Application for FutureFit Homes income-qualified rebates, indicate whether you are currently enrolled in CARE or FERA programs. If you are, that is all that is needed, and SVCE will independently confirm your CARE or FERA status.

2. Income-Qualified Program Enrollment

As an alternative, when submitting the Rebate Claim for FutureFit Homes income-qualified rebates, you can submit a copy of the most recent award letters, acceptance letters, or notice of action from one of the following programs:

Bureau of Indian Affairs General Assistance Head Start Income Eligible (Tribal Only)	
California Unemployment Insurance (UI), Pandemic Emergency Unemployment Compensation (PEUC), or Pandemic Unemployment Assistance (PUA)	
CalFresh/SNAP (Food Stamps)	
Women, Infants, and Children (WIC)	
CalWORKs (TANF) or Tribal (TANF)	
Supplemental Security Income (SSI)	
Free or Reduced National School Lunch Program (NSLP)	
Low Income Home Energy Assistance Program (LIHEAP)	
Energy Savings Assistance Program (ESA)

3. Proof of Qualifying Income

As an alternative, when submitting the Rebate Claim for FutureFit Homes income-qualified rebates, you can submit:

- Copy of most recent Federal Income Tax return, showing gross income documented on W2 or 1099
- Copy of most recent Award or Notice OR Copy of Checks for SSA (Federal) Social Security Administration
