



## SVCE FUTUREFIT FUNDAMENTALS CONTRACTOR TRAINING PROGRAM SURVEY GIVEAWAY OFFICIAL RULES & REGULATIONS

**GIVEAWAY PERIOD:** The Survey Giveaway (“Giveaway”) starts on December 5, 2022 at 12:00 AM Pacific Time and closes on January 13, 2023 at 11:59 PM Pacific Time (“Giveaway Period”).

**GIVEAWAY SPONSOR:** The Giveaway is sponsored by Silicon Valley Clean Energy, which has its corporate headquarters at 333 W. El Camino Real, Ste. 330, Sunnyvale, CA 94087 (“SVCE”). SVCE is responsible for the delivery of the Prize(s) to the winner(s). SVCE’s computer is the official time-keeping device for the Giveaway.

**ELIGIBILITY:** This Giveaway is open to all participants who completed the FutureFit Fundamentals Contractor Training course (“Entrants”). Employees, agents and representatives of SVCE are not eligible to win, nor are the parents, siblings and children of any such employee, agent or representative or any person with whom such employee, agent or representative is domiciled. Different Entrants are not permitted to share the same email address. Any attempt by an Entrant to enter the Giveaway using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant's entries and that Entrant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.
